## The Importance of Parking Lot Security

Crimes like parking lot takeovers are on the rise, and these place vehicles, drivers, and the public at serious risk. In the worst case scenarios, causing death.

As business owners and property managers, you may not be aware of why you need to be responsible for managing parking lot crime when it only appears to impact parking lot users and the public. However, the consequences expand beyond this.

# STEP 1: Organise a Site Survey

Understanding the nature of your site is critical to developing a security plan that caters to and targets the key dangers faced by your parking lot or dealership.

Your site survey should focus on the physical layout of your site, as this will determine the security measures and/or number of surveillance cameras your lot requires.

It will also help determine the best positioning of cameras, where additional signage will be most effective, and any existing systems that can be improved upon.

As a managed security service provider, WCCTV can provide a free site survey as part of our overall survey, however below are some key questions you would need to consider if you wanted to do it yourself.

## STEP 2: Complete a Security Risk Assessment

Once your site survey is completed, the next phase of controlling your security risks is to identify areas of vulnerability at your parking lots or dealerships.

#### When performing a risk assessment, you should:

- Identify the vulnerability
- Assess the likelihood of a security breach occurring
- 3 Assess the severity of loss or damage a security breach could cause

Your risk assessment should focus on two distinct areas:





When identifying the risks at your parking lots or dealerships, you may find it useful to get started with using some of the examples threats we have listed below:				
	Your business has experienced security breaches previously.	Your lot is in a remote location.		
	Your site lacks adequate perimeter fencing.	Your site has no security cameras or guarding services.

Next, you should determine what specific crimes you are likely to face at your parking lot or dealership. Example crimes include:

Understanding which of these crimes is your biggest risk will help determine the type of surveillance solution you need (monitored cameras, LPR reader, video analytics, night vision/thermal cameras, voice-down audio).

#### Most importantly, understand any legalities related to your State:

Different states have different legislation governing the use of surveillance cameras, so it is important you remain ahead of any legal requirement or limitations determined by either your location or application. For example, the specific need to use NDAA-Compliant cameras.

It is also important to ensure you are using US-approved surveillance cameras (for example, many if not all Chinese manufactured surveillance cameras are banned across the US).

## STEP 4: Include People & Processes

Security begins with your employees. Ensure they are fully trained to follow your security protocols, that they understand how to spot security risks, and that you can trust them with your assets.

If you don't already have a security protocol in place, WCCTV can work with you to implement best practices to work alongside our security camera systems.

#### Basic key measures we would recommend include:

- Marking or die-stamping any tools or valuable equipment on-site
- Running regular inventory checks, and keep a log of all goods in and out
- Locking all vehicles overnight
- Installing anti-theft devices in all vehicles
- Use locking gas and oil caps
- Only keeping a minimal amount of gas in any vehicles
- Locking away keys for any vehicles on-site
